The Department of, Forestry, Fisheries, and the Environment (DFFE) has decided to amend the Environmental Authorisation granted on 05 September 2017. The amendment **was granted on 7 February 2024**. The EA is included in the email attached. Reasons, provisions, and conditions of the authorisation are contained in the Authorisation.

Amendments were granted for **picnic site, camping site, and the loop road**. Details can be confirmed in the attached EA.

A new Basic Assessment Process will be undertaken to select a new site for the tented camp.

You may appeal against this decision, according to Chapter 2 of the National Environmental Management Act, 1998 (Act No 107 of 1998) National Appeal Regulations published under Government Notice R993 in Government Gazette No. 38303 dated 08 December 2014 (National Appeal Regulations, 2014) which prescribe the appeal procedure to be followed.

Should you decide to appeal against this decision, you must submit the appeal to the Appeal Administrator and a copy of the appeal to the applicant, any registered Interested and Affected party, and any organ of State with an interest in the matter within **20 days** from the date of this notification.
